Introduction

I did not grow up in the Church, so when I converted to Christ, I had a lot to learn. Tithing was something that I knew nothing about. I found out that Tithing was expected without question; however, it was also without teaching.

I was left with assumptions.

The first assumption was that it was some sort of church tax system. I was used to paying Federal, State, Social Security, and local taxes, so now I am paying a church tax. Just put it on my tab!

My second assumption was that it was part of the religious Law based on the Old Testament. Although I grasped that the New Testament accepted me by grace, I assumed I was still expected to live up to the Law of Tithing.

Again, I couldn't find teaching on the subject. I never once heard my pastor teach on it. He was reluctant, and many were that day, to approach

the subject. They relegated the topic of giving to be taught by TV evangelists, some teaching for self-gain. Truthfully, several ministers teaching on television opened my eyes to see a lot of Scriptures on the subject.

Many of them helped me discover many truths regarding Biblical Economics. The second book I wrote was **God's Currency: The Entrepreneurial Drive**. I want you to have a copy [<https://bit.ly/godscurrency>], or if you would like, you can get a hard copy at FivestarMan.com/books.

I now have close to 40 years of teaching ministry. I have started my ministry with nothing and have had to believe God for everything. Starting two churches, funding them, beginning a travel ministry of consulting, and founding FivestarMan.com have required me to learn much about Biblical Economics.

I preached a message entitled, **Redeemed to Profit** at a great church in the Atlanta area. The Lead Pastor told me that his tithes and offerings grew exponentially afterward. Recently, I preached that message at Evangel World Harvest,

led by Dr. Bob Rogers, who complimented, “Neil, I’ve never heard a better message on Tithing.”

Because of that, I decided to share the foundations of Tithing with you in this book. You will discover some truths that completely change your financial outlook, especially in chapter six, **The Window: Portal to the Unseen Realm**. You need the foundation of the first five chapters before you get there.

Let me give you an appetizer for it.

I am sitting in a room, a box surrounded by walls. A window is over my left shoulder. I cannot see beyond the walls, but I can see through the window outside. The window allows me to be in one space and see another place. The open window allows me access to a portal outside of my box.

Similarly, when God promises to “open the windows of heaven, ” he says he wants to give you access out of your box of time and see into the unseen realm.

He says that the Tithe is the protocol to tap the network of Heaven.

Or consider your phone. It really is a window. The phone is a tablet of glass that allows you to tap into a global network of knowledge, commerce, communication, etc.

One day, I asked the LORD what I could do to reach more men with the message of FivestarMan.com. His Spirit prompted me to read Habakkuk 2:2:

*“Write my answer **plainly on tablets**,
so that a runner can carry the correct message
to others.*

This vision is for a future time.

It describes the end, and it will be fulfilled.

*If it seems slow, wait patiently,
for it will surely take place.*

It will not be delayed.”

For the first time, I saw the word ***tablets*** in a very different light. I realized that we can now reach every man who carries a phone with the message of FivestarMan.com. This revelation changed our strategies when we created the FivestarMan 45-Day Challenge, which reaches thousands of men. It inspires men through the Challenge and empowers them to tell their friends, coworkers, and family members about the positive changes the challenge has had on their lives.

I am excited about this book because I know hundreds of men will start Tithing in worship, experience an open portal to the unseen realm, and tap into Heaven's network. These men will be propelled out of poverty and discover the true meaning of purposed prosperity—they will have the means to fulfill their meaning.

The Genesis of Giving

Genesis 1:29

Then God said, "I give you every seed-bearing plant on the face of the whole earth and every tree that has fruit with seed in it. They will be yours for food."

The Genesis of Giving Begins with God

God is a giver by nature. The very first gift He bestowed upon humanity was the gift of seed-bearing plants. This was no ordinary gift—it was extraordinary. With it, God equipped mankind to meet every conceivable need, fulfilling not only immediate sustenance but ensuring a perpetual cycle of provision through the seed.

2 Corinthians 9:10

"Now he who supplies seed to the sower and bread for food will also supply and increase

your store of seed and will enlarge the harvest of your righteousness.”

If you desire to reflect God’s nature, you will become a giver. Giving originates with God, the Source of all provision. Our giving is not self-initiated; it is a response to the abundant generosity He first demonstrated.

From Abundance to Curse: The Impact of Disobedience

Adam and Eve began in abundance, living in the Garden of Eden—a divine storehouse of provision. Every seed had potential, every river enriched the soil, and every tree yielded beauty and nourishment.

One tree, however, was sacred. God’s explicit instruction was to leave the tree of the knowledge of good and evil untouched. Not all knowledge is good, and God wanted man to be protected from the bad knowledge.

Even though man had access to it doesn’t mean that it would be beneficial to him to have it.

Genesis 2:15-17

“The Lord God took the man and put him in the Garden of Eden to work it and take care of it. And the Lord God commanded the man, ‘You are free to eat from any tree in the garden; but you must not eat from the tree of the knowledge of good and evil, for when you eat from it you will certainly die.’”

This single act of disobedience was Adam’s stewardship test. Yet, when Adam violated God’s command, he embezzled what belonged to the Creator. The consequence was the curse of poverty and struggle. Adam and Eve were expelled from the Garden, and their descendants, including Cain and Abel, were born into hardship.

Marriage: Agreement and Authority

It wasn’t meant to be this way.

God sees that Adam is alone in his work and requires a perfect companion to walk and work in agreement with him—a helper.

At this moment, a unique exercise happens. God parades the animals to walk in front of Adam.

Adam is responsible for naming the animals because God has given him dominion over them. It also distinguishes Adam from all creatures.

Although humans were created with similarities, there is a vast chasm between animals and humans. Humans were made after the image of God and reflected His likeness. Seeing this distinction firsthand was essential to Adam.

By displaying this, God is telling Adam, “You are not to be like the animals; you are to be like Me.”

God then puts Adam to sleep and extracts a bone. Out of the bone, God makes a suitable Helper, named woman (‘iššâ). She is beautiful and has a perfect complementary design to walk equally beside her husband. Together, they form a bond of agreement—marriage. With marriage, Adam and Eve are the superiors of the earth, capable of anything. If two agree on earth, God will agree in heaven.

Matthew 18:19

Again, truly I tell you that if two of you on earth agree about anything they ask for, it will be done for them by my Father in heaven. For

where two or three gather in my name, there am I with them.

Agreement within marriage is a powerful force.

However, agreement requires clear communication and shared purpose. Husbands, your responsibility is to hear from God and lead your wife in faith. Wives must hear your vision to walk in alignment.

Amos 3:3

"Can two walk together, except they be agreed?"

Marriage is not a competition; it is a covenant of completion. When a husband and wife stand united, their work is blessed, their strength is multiplied, and their bond is unbreakable.

**Marriage is designed for completion,
not for competition.**

Let me take a moment and speak to the above statement.

Husbands, you have a responsibility to hear from God. Then, after you have heard from Him, you must turn to your wife and give her faith to follow you.

How do two walk together unless you agree on the destination?

This foundation in marriage will become critical in our future discussion of the Tithe.

Amos 3:3

Can two walk together, except they are agreed?

Ecclesiastes 4:9-12

Two are better than one, because they have a good return for their labor: ¹⁰If either of them falls down, one can help the other up.

But pity anyone who falls and has no one to help them up. ¹¹Also, if two lie down together, they will keep warm. But how can one keep warm alone? ¹²Though one may be overpowered, two can defend themselves. A cord of three strands is not quickly broken.

Five Keys to Walking in Agreement According to Ecclesiastes 4:9-12

1. Mutual Benefit

Two get a better return for their work. Their work was blessed as long as Adam and Eve walked in accord.

2. Shared Warmth

If two people lie down together, they will keep warm. Lying together creates a warm connection and intimacy. I strongly recommend that you stay in the same bed at night. When King David was old and chilled, Abishag became his concubine to keep him warm.

3. Combined Strength

“And though a man might prevail against one alone, two will withstand him—a threefold cord is not quickly broken.” We have opponents. We must have a marriage that stands together against those who oppose us.

4. Unity in Purpose

Walking in agreement requires shared goals and a unified front. If either party in the relationship is unaware of the purpose, they will not agree.

5. Open Communication

Honest and open communication is essential for resolving conflicts and maintaining unity. It is giving faith to follow. Your wife must hear from you to believe and trust where you're going. Faith comes by hearing, and hearing comes by the Word. Likewise, her confidence in direction will come from hearing from you.

However, an enemy of marriage, the Deceiver, desires to bring a wedge between the husband and wife. He will use a variety of schemes that we should not be ignorant of.

The subtle skill of deception is evident in the snake's approach to Eve. First, the snake usurped the husband's authority to approach Eve. Adam served the LORD under the protocol of authority, which is designed to protect, provide, promote, and empower those within it.

Ephesians 5:21-27

Submit to one another out of reverence for Christ. Wives, submit yourselves to your husbands as you do to the Lord. For the husband is the head of the wife as Christ is

the head of the church, his body, of which he is the Savior. Now that the church submits to Christ, wives should also submit to their husbands in everything.

Husbands love your wives, just as Christ loved the church and gave himself up for her to make her holy, cleansing her by the washing with water through the word, and to present her to himself as a radiant church, without stain or wrinkle or any other blemish, but holy and blameless.

Paul reveals a clear protocol of authority that is designed to protect us from deceptive forces:

- **Christ is submitted to the Father.**

John 8:28: *“When you have lifted up the Son of Man, then you will know that I am he and that I do nothing on my own but speak just what the Father has taught me.”* It is not demeaning for Christ, who is equal to the Father, to serve in submission to the Father.

- **Men are submitted to Christ.**

Verse 21, *“Submit to one another out of reverence for Christ.”* Also, James 4:7: *“Submit*

yourselves therefore to God. Resist the devil, and he will flee from you." It is not demeaning for a man to be submitted to God through Christ.

- **Wives are submitted to their husbands.**

Verse 22, *"Submit yourselves to your husbands as you do to the Lord."* It is not demeaning for wives to be submitted to their husbands.

- **Children are submitted to their parents.**

Ephesians 6:3: *"This is the first commandment with a promise: If you honor your father and mother, 'Things will go well for you, and you will have a long life on the earth.'"* It is not demeaning for children to be submitted to their parents.

The Protocol protects, provides, promotes, and empowers through the line of authority. It begins with the Word of the Father, revealed in Christ, who is the Word that became flesh, spoken, and received by men and women to raise godly offspring.

The husband is directed to love their wives as Christ loves the Church and uses the Word to protect them from deception.

This warning is appropriate because Adam failed to protect his wife from the snake. Adam was given dominion over everything that crept on the ground. All Adam had to do was put his foot down. Unfortunately, he allowed the snake to question God's Word and bring doubt to her identity.

Men, there will be times when you must 'put your foot down' to protect your wife, your home, and your work.

The Deceiver's Scheme

The serpent's approach to Eve was deliberate, undermining the protocol of authority God had established.

Genesis 3:1

"Did God really say, 'You must not eat from any tree in the garden'?"

The serpent's strategy was deception, introducing doubt and twisting God's Word. Eve's response revealed misunderstanding: "You must not touch it," she added—an addition not

commanded by God. The serpent exploited this misstep, persuading her to disobey.

Adam failed to protect his wife. As the one given dominion over creation, Adam should have silenced the serpent. His abdication of responsibility opened the door to sin.

Sin opened the door to poverty, destruction, and death.

They were expelled from the Garden. Adam was terminated from his job. His property was repossessed. An angelic guard was assigned to protect the Trees from Adam's mismanagement. He hid in shame and lost the respect of his wife. His sons were born into poverty. His work became labor.

Adam could no longer be trusted with God's gift of seed. He became nomadic, wandering the Earth looking for a purpose and laboring against thorns and thistles.

Eve was assigned pain during childbirth. Adam was assigned pain in work.

This is the environment that Cain and Abel are born into: poverty, subsistence living, or, as we say, “living pay-check to pay-check.”

Something had to change.

Change will only happen when the pain of staying the same is greater than the pain of doing something different.

Hebrews 11:4

“By faith, Abel brought God a better offering than Cain did. By faith, he was commended as righteous when God spoke well of his offerings. And by faith, Abel still speaks, even though he is dead.”

Abel stands as the first recorded man of faith. Think about being the first man ever recorded to have faith.

Consider this: Abel, amidst the trials of life, inherently recognized that God was worthy of worship. His response was to offer the firstborn of his flock—an act of gratitude and reverence. We must delve into what drove him to this

expression to grasp the significance of Abel's faith.

The First Offerings: A Distinction of Heart

Genesis 4:2-5

"Now Abel kept flocks, and Cain worked the soil. In the course of time, Cain brought some of the fruits of the soil as an offering to the Lord. And Abel also brought an offering—fat portions from some of the firstborn of his flock. The Lord looked with favor on Abel and his offering, but on Cain and his offering, he did not look with favor. So Cain was very angry, and his face was downcast."

The first recorded offerings to God were given by two brothers, Cain and Abel. Yet, one offering pleased God, while the other did not. Why? The answer lies in the quality and heart behind the gifts.

Cain presented "some of the fruits," while Abel gave the "fat portions of the firstborn."

Cain's offering was casual; Abel's was intentional. The distinction was not the type of offering—plants versus livestock—but the motivation and apportionment. Abel brought the first and best, while Cain merely brought some.

Throughout Scripture, God honors the first—the Tithe.

This principle reflects faith and trust in God as the ultimate provider. Abel's offering revealed a heart of faith, while Cain's exposed indifference.

Cain gave a tip; Abel gave the Tithe.

Faith In Action: Abel's Legacy

Abel stands as a towering figure in the story of humanity—not for his strength, wealth, or position, but for his faith.

Remember, Abel was born into desperate poverty due to his father's embezzlement. He deeply desired to turn his labor into favor.

But how could he break through the barrier of mediocrity and restore wealth to his life and family?

Abel was the first man to express faith in God through giving. His offering was more than a ritual; it was an act of worship, trust, and reverence. His legacy teaches us the profound faith aspect of tithing and what it means to give to God by faith, not sight.

The Faith of Abel: Tithing as Worship

Hebrews 11:4

“By faith Abel brought God a better offering than Cain did. By faith he was commended as righteous when God spoke well of his offerings. And by faith Abel still speaks, even though he is dead.”

Abel’s act of giving was rooted in faith. While his brother Cain presented some of his produce, Abel gave the first and best portions of the firstborn of his flock. His offering was not merely a portion of his income but the most valuable part—the firstborn. This was his Tithe.

Abel’s faith demonstrated three essential truths about Tithing:

1. **Tithing as an Act of Worship**

Abel’s gift wasn’t just about the material value of what he gave. It was about honoring God as the Source of all he had. By giving the first and best, Abel acknowledged God’s sovereignty and demonstrated his dependence on Him.

2. **Faith Over Fear**

Abel didn't hold back, wondering if more flocks would come. He gave in faith, trusting that the God who provided the firstborn would continue to provide.

3. **A Response to God's Character**

Abel's offering revealed his understanding of who God is—a gracious provider who is worthy of the best.

Giving by Faith, Not by Sight

2 Corinthians 5:7

"For we live by faith, not by sight."

You will never give your best if you do not believe in the best of God's character.

To give by faith means to trust in God's provision rather than relying on what you see or have at the moment.

Abel's story illustrates this beautifully. He gave his firstborn lambs when he could not yet see how his flock would multiply. By offering the best before ensuring his own future security, Abel declared his confidence in God's faithfulness.

This principle remains true today. Giving the first 10%—the tithe—requires faith, especially when resources seem limited. It demands trust in the promise that God will meet your needs and bless your obedience.

Approaching God with Faith

Hebrews 11:6

“And without faith it is impossible to please God, because anyone who comes to him must believe that he exists and that he rewards those who earnestly seek him.”

Abel approached God with faith, believing that He is both real and responsive. Faithful giving is an expression of seeking God earnestly, trusting Him to be the Rewarder of those who put Him first.

When we tithe by faith, we declare:

- **God is my Provider.**

Tithing affirms that your trust is not in your job, your business, or your abilities, but in God’s unlimited resources.

- **God is faithful to His Word.**

The tithe is a test of trust. When we obey, we align ourselves with His promises to provide and bless.

- **God is worthy of my best.**

Giving by faith means offering the first and best portion—not what's left over—because God deserves our best.

Practical Steps to Give in Faith

Faith in action requires intentionality. Here are practical steps to help you give in faith, following Abel's example.

Prioritize the Tithe

Set aside the first 10% of your income for God before you allocate resources to anything else. This intentional act demonstrates trust and honors Him as your Provider.

Pray Over Your Giving

Have confidence that what you are doing is an act of worship. You're not paying a bill. You are expressing your faith. Before you tithe, take a moment to pray. Acknowledge God as the source

of your provision and express your trust in His faithfulness.

Give Joyfully

2 Corinthians 9:7 reminds us, “God loves a cheerful giver.” Faith-filled giving is not done grudgingly or out of obligation but with joy, knowing that God delights in your trust.

Align with God’s Promises

Anchor your giving in Scripture. Meditate on verses like Malachi 3:10, which promises that God will “open the windows of heaven and pour out blessings” for those who tithe. Let His Word fuel your faith.

Trust Beyond Immediate Results

Faithful giving doesn’t always yield instant results, but trust that God’s timing is perfect. Continue to sow faithfully, believing in His ability to reward and provide abundantly.

Faith as a Tangible Substance

Hebrews 11:1-2 (NKJV)

“Now faith is the substance of things hoped for,

the evidence of things not seen. For by it the elders obtained a good testimony."

Faith is often perceived as an abstract, intangible concept—a mere belief or mental assent to something we cannot physically touch. However, Hebrews 11:1 challenges this misconception by describing faith as something very real, very tangible, and with a substance that is as concrete as any material thing.

The writer of Hebrews gives us a powerful understanding of faith that moves beyond mere thinking or imagining—it's a force that has the power to shape reality.

1. Faith as the Substance of Things Hoped For

The first phrase in Hebrews 11:1 says, *"faith is the substance of things hoped for."*

The word "substance" here comes from the Greek word ***hupostasis***, which means "standing under" or "foundation."

It is the same concept as the Protocol of Authority that we spoke of earlier. It refers to the

essence, reality, or the very structure that underpins something. In essence, faith is the foundation upon which our hope rests.

Faith is not a fleeting feeling or wishful thinking. It is the bedrock of our expectations and the assurance that what we hope for will come to pass. Just as a building needs a strong foundation to stand firm, our hopes and dreams—those things we are believing for—are anchored in the solid substance of faith. Faith gives our hopes substance; it makes them real and tangible in the spiritual realm.

To illustrate this, imagine a blueprint for a building. The blueprint is a picture of something that has not yet been built, but faith acts as the material that will bring that blueprint into physical reality. In the same way, the desires and promises we have are not mere fantasies—they have weight and structure when viewed through the lens of faith. Faith is the “material” that shapes them.

2. Faith as the Evidence of Things Not Seen

The next part of Hebrews 11:1 tells us that faith is “the evidence of things not seen.” The word “evidence” here comes from the Greek word *elegchos*, which refers to proof, conviction, or a demonstration of something that is real. In legal terms, evidence is used to support the truth of a claim. Similarly, faith is the evidence that supports the truth of God’s promises, even though we may not yet see them with our natural eyes.

Faith makes the unseen visible in the spiritual realm, even when our natural senses perceive no tangible proof. It is like a legal document that proves ownership or a receipt that guarantees a purchase. In the unseen realm, faith operates as the proof that what God has promised will come to fruition.

This is where many people get confused: they think that faith is something mystical or disconnected from reality. But faith is deeply grounded in the truth of God’s Word. When we believe God for something—whether it’s healing, provision, peace, or a breakthrough—we may not

immediately see it, but our faith is the evidence that God's promises are sure and will come to pass. Just as a building is real and tangible when the blueprint is followed, our hopes become tangible when they are rooted in faith.

3. Faith is Not a Mystical Idea; It is a Tangible Force

While faith may be invisible to the naked eye, it is not mystical or ethereal. Faith is a force that has substance, impact, and power. It is a real, tangible thing in the spiritual realm that can shape the physical world. To understand this, we need to look at the lives of those who have lived by faith, as Hebrews 11:2 tells us, "For by it the elders obtained a good testimony." These "elders" or heroes of the faith demonstrated that faith is something far more than mere belief; it is something that produces results.

Consider the examples given in Hebrews 11—the lives of Abel, Noah, Abraham, Sarah, Moses, and others. These men and women did not merely hope in the abstract. Their faith produced tangible results. Abel's offering was accepted by God because it was offered in faith (Hebrews

11:4). Noah built an ark because he believed God's warning about an unseen flood (Hebrews 11:7). Abraham left his homeland to pursue a promise of descendants and land that he could not yet see (Hebrews 11:8-10). These are not acts of blind faith or mystical experiences; they are grounded in the concrete substance of trust in God's Word.

In the same way, when we put our faith in God's promises, we are engaging with a tangible, powerful force. Faith is not just a vague or abstract concept; it is the real, spiritual substance that brings the unseen into the seen. It enables us to receive the promises of God, even if those promises are not yet visible to the human eye.

4. The Practical Application: Faith in Action

So, what does this mean for us in a practical sense? If faith is a tangible substance and evidence, then it requires action. Faith is not passive. It demands that we act in accordance with what we believe, even when we do not yet see the fulfillment of our hopes.

Believe God's Promises

The first step is to believe that God's promises are real and that they are for you. Read the Scriptures, and take God's promises to heart. Faith comes by hearing the Word of God (Romans 10:17), so fill your mind with what God has said about you and your situation.

Act on Your Faith

Faith without action is dead (James 2:17). Just as Noah built the ark and Abraham left his home, you must take steps in accordance with your faith. This might mean making decisions that align with your trust in God's provision, health, guidance, or protection, even if you cannot yet see the result.

Expect to See Results

Faith expects the invisible to become visible. Just as you would wait for the construction of a building once its foundation is laid, expect God to bring about what you have believed for. Your faith is the assurance that what you hope for will materialize, just as the blueprint of a building is made into reality with time and effort.

Persevere in Faith

Often, there may be a waiting period between the moment you exercise faith and the time you see the manifestation. During this time, stand firm in your belief. Your faith is not futile—it is working in the unseen realm to bring about the things you hope for.

Conclusion: Faith—A Tangible Substance That Transforms Reality

Hebrews 11:1 reveals faith as far more than just a philosophical or mystical idea. Faith is a tangible substance, the very foundation of our hopes and the evidence of God's promises, even when they are not yet visible. When we live by faith, we engage with the unseen, knowing that God will bring our hopes into reality. By aligning our actions with our faith, we participate in the divine process that transforms the invisible into the visible.

Faith, in this sense, becomes a spiritual force that affects our lives, circumstances, and the world around us. It is not a passive or theoretical concept, but a powerful, tangible substance that brings God's promises into being. When we

embrace faith in this way, we can confidently walk through life, knowing that we are not just hoping in something uncertain, but standing firm on the solid foundation of God's Word, certain that the invisible will become visible in His perfect timing.

The Reward of Faithful Giving

Abel's legacy reminds us that God sees the heart behind the gift. His offering was accepted because it was given by faith, and God "spoke well of his offerings." This divine commendation reveals that God is pleased when we give in faith.

Malachi 3:10

"Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this," says the Lord Almighty, "and see if I will not throw open the floodgates of heaven and pour out so much blessing that there will not be room enough to store it."

The reward of faithful tithing is not just material blessing but the assurance of God's favor and provision.

Abel's faith still speaks today, calling us to trust God fully and honor Him with our best.

In fact, God is so determined that Tithing is an act of giving in your life, He makes a promise to you, saying, "Test me in this..."

The Principle of The First

Genesis 14:18

Then Melchizedek, king of Salem, brought out bread and wine. He was priest of God Most High, and he blessed Abram, saying, "Blessed be Abram by God Most High, Creator of heaven and earth. And praise be to God Most High, who delivered your enemies into your hand." Then Abram gave him a tenth of everything.

Abram practiced Tithing.

Abram used his household servants, who were well-trained for battle, to rescue five kings. It was customary that when you won a battle, the spoils of war became the possessions of the victor.

Tithe

After delivering the kings from defeat, Abram approached Melchizedek, the Priest. This figure is crucial in understanding the Tithe.

Before Abram divided up the spoils, he set aside the Tithe as the First.

Rather than keep the spoils, Abram refused, saying, “With the raised hand, I have sworn an oath to the Lord, God Most High, Creator of heaven and earth, that I will accept nothing belonging to you, not even a thread or the strap of a sandal so that you will never be able to say, ‘I made Abram rich.’

Tithing is not just an act of generosity or financial strategy; it is an expression of alignment with a divine principle woven throughout history. The Principle of the First is one of the most powerful and transformative aspects of tithing. It speaks to the very heart of our faith, our priorities, and our trust in the provision of God.

The concept of giving the “first” and “best” portion of our resources is not a new idea. It has deep roots in the biblical narrative and spiritual

practice, shaping how we approach God and our wealth. This chapter will explore the historical, biblical, and psychological significance of this principle and why it matters in the practice of tithing.

Historical and Biblical Insights into the ‘First Fruits’

Giving the first portion of our harvest, wealth, or income is foundational to Jewish and Christian faiths. It is deeply embedded in the concept of “first fruits” found throughout the Bible. Matthew 6:33

“But seek first his kingdom and his righteousness, and all these things will be given to you as well.”

While everyone else seeks clothes, cars, and cottages, the man who seeks God demonstrates it with the Tithe.

In the book of Proverbs, we read, *“Honor the Lord with your wealth, with the firstfruits of all your crops; then your barns will be filled to overflowing, and your vats will brim over with new wine”* (Proverbs 3:9-10). This passage makes it clear that when we give God the first of our wealth, He responds by blessing us abundantly.

However, when we give the first portion—before we see how the rest of our needs will be met—we are expressing a deep trust in God’s faithfulness.

We are saying, “I trust You, God, to meet all of my needs, even before I see how You will do it.”

This trust is not passive but active. It is a faith that requires us to step out of our comfort zone and choose to believe that God will provide.

In Matthew 6:33, Jesus instructs us, *“But seek first His kingdom and His righteousness, and all these things will be given to you as well.”*

The principle of the first is an embodiment of this command. When we seek God’s kingdom first, we acknowledge that He is our priority, and

Whether it's the first moments of our day spent in prayer or the first decision we make in a financial transaction, prioritizing God in these small moments leads to a life marked by peace, abundance, and purpose.

There is power in putting God first. It reorders our priorities and invites Him to lead every area of our lives. When we choose to give God the first of what we have, we are creating space for Him to move in powerful ways, both spiritually and practically.

The Principle of the First is an act of faith. It is putting faith into action. In fact, as Abel demonstrated, Tithing is the first act of faith.

The Test of Obedience

Malachi 3:10

“Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this,” says the Lord Almighty, “and see if I will not throw open the floodgates of heaven and pour out so much blessing that there will not be room enough to store it.”

The Tithe is far more than a financial obligation—it is an expression of the heart worshiping God. From the earliest days of humanity, as seen in the story of Abel, giving has been an act of faith and reverence toward God. However, over time, the Israelites began to neglect this sacred practice, prompting God to establish the tithe in the Levitical law.

In Malachi 3:10, God challenges His people:

“Bring the whole tithe into the storehouse, that there may be food in my house. Test me in this,” says the Lord Almighty, “and see if I will not throw open the floodgates of heaven and pour out so much blessing that there will not be room enough to store it.”

This verse highlights the tension between the Israelites’ disobedience and God’s desire to bless them. While the law served as a framework to guide their giving, God’s ultimate purpose was to draw His people into a heart-centered relationship where giving was an act of worship, not mere compliance.

When the heart is absent, the Law is required.

Tithing: A Matter of Worship, Not Just Law

Hebrews 7:1-10 provides a profound contrast between tithing as a legal requirement and tithing as an act of worship. This passage refers to Abraham giving a tithe to Melchizedek, a priest of the Most High God. This moment occurred long before the establishment of the Levitical law,

demonstrating that tithing is rooted in faith and relationship with God, not legal obligation.

Key Points from Hebrews 7

- **Abraham's Tithe to Melchizedek**

Abraham gave a tenth of the spoils to Melchizedek after his victory in battle. This act was spontaneous and voluntary, rooted in gratitude and reverence for God's provision and blessing. It was not mandated by law but inspired by worship.

- **A Higher Priesthood**

Melchizedek's priesthood is described as eternal, foreshadowing Christ's role as our High Priest. This shows that Tithing transcends the Levitical system, aligning with the eternal order established by Christ.

The passage emphasizes that Levi, through Abraham, effectively paid Tithes to Melchizedek, showing that the principle of Tithing is greater than the Levitical law. It originates from a heart of honor and faith, not mere duty.

The Israelites' Failure: A Heart Issue

The Israelites' neglect of the Tithe, as addressed in Malachi 3:8-10, was not just disobedience to a law—it revealed a deeper problem of the heart.

They failed to honor God as their Provider and Sustainer. Instead of bringing the first and best, they withheld, prioritizing their own needs, cravings, and desires over worshiping God.

God instituted the Tithe in the law not to burden His people but to teach them dependence, trust, and reverence.

It was a test of obedience designed to draw their hearts back to Him. However, over time, many reduced Tithing to a legalistic practice, missing its true purpose as an act of worship.

Many people today are giving as Cain gave, a token or a tip rather than the Tithe.

***You tip the one who serves you;
you Tithe to the One whom you serve.***

The Heart of Worship in Tithing

Tithing as worship requires a shift from obligation to devotion. It is not about fulfilling a rule but about expressing love, gratitude, and trust in God.

Key Contrasts Between Worship and Law in Tithing:

Motivation

Under the Law, Tithing was often seen as an obligation to avoid punishment. As worship, Tithing flows from a heart that desires to honor God for who He is and what He has done.

Perspective

Under the Law, Tithing was a transaction—something given to fulfill a requirement. As worship, Tithing is relational—an offering that acknowledges God as the source of all blessings.

Faith

Under the Law, obedience to the Tithe could be devoid of faith, done out of routine. As

worship, faith is central, trusting God to provide and bless in response to giving.

The Test of Obedience Today

Even today, Tithing serves as a test of obedience, revealing where our hearts are. You've heard this a thousand times: God does not need our money, but He desires our hearts. Money represents you. It is the accumulation of your time, energy, work, creativity, and labor. You are simply using money as the currency to express the intangible commodities.

The act of bringing the first 10% of our income to Him is a declaration that He is first in our lives.

Practical Steps to Tithe as Worship

1. Start with the Heart

Before giving, examine your motives. Are you tithing out of obligation or as an act of gratitude and faith?

2. Honor God First

The principle of the firstfruits remains significant. Give the first and best portion of your income, trusting God with the rest.

3. Trust His Promises

Meditate on Scriptures like Malachi 3:10 and 2 Corinthians 9:8, which remind us that God is faithful to bless those who give cheerfully and sacrificially.

4. Be Consistent

Worship requires consistency. Make tithing a regular part of your spiritual discipline, reflecting your ongoing trust in God.

Christ and the Heart of Giving

In Christ, we are no longer bound by the law, but the principles of Tithing remain relevant as a means of worship.

Jesus affirmed this in Matthew 23:23, where He rebuked the Pharisees for neglecting justice, mercy, and faithfulness while meticulously Tithing. His words remind us that tithing should never be reduced to legalism but must flow from a heart aligned with God's purposes.

Under the New Covenant, Christ's sacrifice fulfills and transcends the law. As believers, we are called to give generously and sacrificially,

reflecting the heart of worship Abel exhibited and Abraham demonstrated to Melchizedek.

In this mysterious figure, we see a shadow of the eternal, unchanging priesthood of Jesus. The giving of and worship with the Tithe in this encounter is not simply a financial transaction; it is a spiritual act of worship, recognizing God’s

The parable illustrates the responsibility of managing the resources God has entrusted to us, and the rewards for those who use them wisely.

The Parable Summary

A wealthy master, before going on a journey, entrusts his servants with different amounts of money, referred to as “talents” (a large sum of money). He gives five talents to one servant, two to another, and one to the third, according to their abilities. Upon his return, the master asks for an accounting. The servants who invested their talents wisely and made a profit are praised and rewarded with greater responsibility. However, the servant who hid his talent in fear and did nothing with it is reprimanded and cast away.

Key Teachings on How to Profit

God Entrusts Us with Resources

The master in the parable represents God, and the talents represent the resources, gifts, opportunities, and abilities He gives to each of us. Whether these talents are financial, intellectual, relational, or spiritual, they are all God's provision, entrusted to us for growth and increase. Jesus teaches that we must recognize that everything we have is a gift, and we are stewards of what God has provided.

Profiting Requires Action

Jesus emphasizes that profiting, or increasing what God has given, requires proactive effort. The two servants who were entrusted with five and two talents immediately put them to work, investing and trading to generate more. In contrast, the servant who received one talent was paralyzed by fear and chose to hide it instead of using it. Jesus is teaching that faithfulness and action are necessary for increase. Without taking risks or stepping out in faith, there can be no profit.

Stewardship Equals Responsibility

The parable illustrates that God expects us to manage what He gives us with responsibility. The servants were entrusted according to their abilities, which shows that God is fair in His expectations. We are not expected to use resources beyond our capacity, but we are accountable for how we handle what we've been given. The master's response to the profitable servants—"Well done, good and faithful servant"—shows that God rewards faithful stewardship.

The third servant's downfall was his fear. Instead of taking action, he buried his talent, afraid of losing it. Jesus teaches that fear of failure or the unknown can paralyze us and prevent us from stepping into the opportunities God has provided. In God's kingdom, fear is not an excuse for inaction. We are called to trust Him and take bold steps of faith, knowing that He will empower us.

Multiplying Talent is a Sign of Faithfulness

The servants who invested their talents and multiplied them demonstrated their faithfulness to the master. Jesus connects profit and increase

with spiritual faithfulness. It's not just about making money or gaining more resources; it's about showing that we can be trusted with the little things so that God can entrust us with more. The act of multiplying, of making something grow, reflects a heart of trust and obedience to God.

Kingdom Profit is about More than Material Gain

While the parable involves financial talent, the deeper meaning goes beyond money. Profiting in the kingdom of God also involves growing in spiritual gifts, wisdom, and influence. Kingdom profit is about eternal impact, not just earthly wealth.

Practical Application of How to Profit

In the fleeting nature of life on earth, it is easy to become consumed by the pursuit of temporary wealth, comforts, and pleasures. Yet, as followers of Christ, we are called to a higher purpose—one that transcends the material and embraces the eternal.

Living and Leaving a Legacy
